CRACKS have started showing in the ANC's tripartite alliance and its leagues in the run-up to its 55th national elective conference, expected to be held in Nasrec in December, with members disgruntled with President Cyril Ramaphosa's leadership.

The long-standing relationship between the ANC, the SACP and Cosatu was dealt a blow last month after the trade union's assertion at its 14th national congress that it would support the SACP in the 2024 general election.

If Cosatu has its way, the SACP and the ANC will for the first time contest each other, putting the Ramaphosa-led ruling party in a tight spot.

At the congress, Ramaphosa's ally ANC chairperson and Minister of Energy and Mineral Resources Gwede Mantashe, who was meant to give a message of support on behalf of the party, was jeered and booed off stage.

Cosatu and the SACP backed Ramaphosa in 2017 in a desperate move to sever ties with the Jacob Zuma faction led by Minister of Co-operative Governance and Traditional Affairs Dr Nkosazana Dlamini Zuma.

She was defeated, but the two are again expected to face off in the elective conference in December.

Although Cosatu, the SACP, the ANC Youth League and the ANC Women's League, including alliance partner the SA National Civic Organisation, could not divulge who they were going to support at the upcoming ANC conference, they seemed to be unhappy with the Ramaphosa-led ANC.

# **MPs back Bawa's refusal to recuse herself**

THE Section 194 Committee yesterday accepted the decision by evidence leader Advocate Nazreen Bawa not to recuse herself from the inquiry into the fitness of Public Protector Busisiwe Mkhwebane to hold office.

The inquiry received a recusal application for Bawa last week from UDM leader Bantu Holomisa and Godrich Gardee Attorneys, acting on behalf of chairperson of Black People's National Crisis Committee, Chumani Maxwele.

In his letter, Holomisa said it had

come to his party's attention that Bawa was implicated in legal proceedings that called her conduct into question.

In a separate letter, Gardee said Maxwele was aware of proceedings in the Western Cape High Court where allegations were made against Bawa in June 2020, but were not substantively addressed by the legal Practice Council and the Cape Bar Counsel.

He said the records relating to Bawa's alleged misconduct were before the high court and had been resubmitted to both the legal Practice Council and Cape Bar Counsel.

Yesterday, Bawa said the complainants relied on an affidavit of Xulu Barnabas of B Xulu & Partners Incorporated in an ongoing litigation involving the Department of Forestry, Fisheries and Environment.

Bawa has been acting in that litigation on behalf of the department since August 2019.

She told the MPs that the complainants have no knowledge of the allegations and solely relied on whatever information they got from Xulu's affidavit. "They appear to labour under a misconception that there exists a 407-page affidavit which, in its entirety, impugns my reputation and seeks to implicate me in some sort of criminality, which I have not figured

out what, and which I have some obligation to respond (to) whether in court or in some unspecified criminal or other process."

Bawa also said she respectfully declined the invitation to recuse herself as the evidence leader before the committee as a consequence of what is occurring in those proceedings.

"I am also not a decision-maker, nor a member of this committee. The complainants have not pointed to anything done during this enquiry that warrants my removal. Of course, the decision is ultimately one the committee would inadvertently have to make," she said before delving into details of the litigation. Holomisa said the committee had a duty to hear both sides of the story and also ask Xulu to give his version.

"She has made serious allegations of dishonesty against Xulu. The committee should not give oral presentation to the evidence leader without affording the same opportunity to those who accuse her of wrong doing," he said.

DA MP Kevin Mileham said Bawa was not the person to be investigated or take further action against.

"The allegations made by the various complainants are completely unsubstantiated," Mileham said.

## ENERGY Up to Eskom board to evaluate CEO's performance - David Mabuza

DEPUTY President David Mabuza yesterday said it was up to the Eskom board to act against CEO Andre de Ruyter and his executives after evaluating their performance.

"It is up to the newly-appointed board to re-evaluate the performance of Eskom CEO and other members of Eskom management and, if indeed they find that there is poor performance, I think it is up to the board to act," Mabuza said.

He was responding to oral questions in the National Council of Provinces from EFF MP Mmabatho Mokause on why De Ruyter had not been removed from office despite failing to ensure that there was reliable and affordable electricity.

Mokause also asked whether Public Enterprises Minister Pravin Gordhan had provided the newly-elected board with a clear mandate regarding the level of capability and management experience that was necessary to guarantee Eskom affordable power and reliable generation capacity.

Mabuza said they were pleased that for the first time in a long period, all 13 vacancies on the Eskom board have been filled with a variety of expertise.

"The board will focus on problems with power generation and energy -related issues, fighting fraud and corruption."

to be financially stable and geared towards meeting its developmental imperatives."

Asked at what stage of the "blackouts" consideration would be taken to bring black executives to Eskom to help end the country's energy crisis, Mabuza said the government, as a shareholder, appointed the board to administer and oversee operations of the utility.

"We should refrain as the shareholder from interfering in the daily running of the entity. Now that we appointed the board we have done a good job," he said.

Mabuza said it was up to the board to evaluate the employees at Eskom, including De Ruyter.

"The board will then after evaluation... be in a position to say there is a gap in skills that is in the utility and if a skill is not found in the country, the board escalates it to the shareholder," he said.

"As much as we see the challenges faced by Eskom, we should allow the board we appointed to turn the affairs of Eskom and not interfere as the government, "Mabuza added.

Pressed to answer in light of the CEO's lack of performance that filtered to his subordinates, what measures would keep employees accountable when they did reach performance targets, the deputy president said they have given all powers to the newly-appointed board in terms of shareholder's agreement. "The board should evaluate performance, why there is load shedding, why there are breakages and finally take a decision. If the decision says there is under-performance, they must act in a way to bring confidence and stability to the entity," Mabuza said.
