# Philippi crime spree ends with life sentence for Gwazekhaya

CONVICTED of 21 crimes, Siphenkosi Gwazekhaya, 27, will serve life behind bars for traumatising the community of Philippi through his criminal actions.

Judge Nonthuthezlo Ralarala

handed down sentence in the Western Cape High Court yesterday saying Gwazekhaya's crime spree had deeply affected those who he targeted.

Gwazekhaya faced multiple charges including murder, attempted murder, kidnapping, robbery with aggravating circumstances, possession of firearms and ammunition and various contraventions of the Firearms Control Act.

Reflecting on victim impact statements heard in closing arguments, Judge Ralarala said the actions of Gwazekhaya, also known as Bhoyoyo, resulted in victims living in fear in their community and they were violated in their homes through his brazen crim-

The court heard that the lives of families who were victims of housebreaking and robbery with aggravating circumstances, were "transformed forever, for the worse", and victims had to move from the area. An attempted murder victim continues to suffer from discomfort in his leg due to a gunshot

The judge added that his continued acts of violence, often committed in broad daylight and with a total disregard for the lives of the deceased and attempted murder victims, was evident of the prevalence of violence across the country.

The murder committed was when a taxi owner's son was kidnapped and then taken to his father's house so Gwazekhaya could steal a legally-owned firearm.

A struggle ensued and the taxi owner was shot dead in his home. According to court details, the deceased was shot six times - three of the bullet wounds were to his head.

The seriousness of these crimes can't be emphasised enough. The manner in which the robberies and housebreaking happened is very concerning. There was a thought process and planning that went into it as the same modus operandi was used.

"You shamelessly traumatised the community. You committed these crimes in their homes - which are their sanctuaries. Through the victim impact statements we heard the voices of the victims. There was no form of remorse shown throughout proceedings. Even after conviction, you insist on your innocence," said Judge Ralarala.

Two victims affected by the crimes of Gwazekhaya attended the proceedings yesterday morning. Sisters, Nom-nikelo and Anelitha Mbombo, welcomed the life sentence handed down to the man who broke into their home.

"We are feeling so grateful that the judge made the right decision. We believe justice has been served and it's what we wanted," they said. National Prosecuting Authority

(NPA) spokesperson, Eric Ntabazalila, highlighted that the crime spree occurred in the Philippi area from 2017 until 2020. "The accused and other unknown

co-perpetrators robbed legal owners of their firearms. The *modus operandi* were to approach the houses when children were alone at home, break into the houses and assault and threaten the minors to gain entry to safes and rob the firearms and ammunition held.

"The accused and unknown group approached a group of City of Cape officials who during the Covid period was repairing the water connection in the Philippi area and robbed them of all their belongings and shot one official. The victim was left with a lifelong disability and these co-workers are traumatised to this day," said Ntabazalila.

## Cops reveal how they caught 7 people including teen for Philippi massacre

A 16-year-old is among the seven suspects that have been arrested in connection with the murder of seven men in Philippi nearly a week ago.

In what police described as a decisive blow to violent crime, detectives attached to the Provincial Serious and Violent Crimes Unit, with the support of Crime Intelligence, arrested the suspects aged between 16 and 22 on Wednesday night and early on Thursday morning in Philippi East.

Police spokesperson Andre Traut said the arrests mark a significant breakthrough in the ongoing effort by police to stamp out violent and organised crime across the province. He said the suspects were traced and arrested during a series of well-coordinated operations that followed days of intensive investigation and intelligence-driven efforts.

Police provincial commissioner

Thembisile Patekile hailed the swift and professional actions of both the detectives and Crime Intelligence, describing the arrests as a clear message to those who perpetrate violence.

"We will not tolerate ruthless acts of violence that destroy lives and destabilise our communities. The men and women of the South African Police Service - supported by our intelligence capability - will continue to hunt down those who commit such barbaric crimes. There will be no hiding place for criminals in this province," said

Patekile. Western Cape police top brass reaffirmed its zero-tolerance approach to violent crime and assured communities that the SAPS will continue to pursue every lead until all those responsible are brought to justice.

Among the seven slain men was 28-year-old Maphelo Msuthu, who, according to his family, will be buried in the Eastern Cape on November 1.

His family previously told the Cape Times that Msuthu was selling insurance in malls around Cape Town with three other young men who are from the same village in the Eastern Cape.

"They were moving around, going to places selling insurance in different malls. He was only there for three weeks. He stayed in Khayelitsha before he moved to Philippi," said his uncle


Police Oversight and Community Safety MEC Anroux Marais commended members of the SAPS Provincial Serious and Violent Crimes Unit and Crime Intelligence for tracing and arresting the suspects.

"I want to extend my congratulations to the members for their exceptional work in this case. Their relentless pursuit of justice and their actions to swiftly track down and arrest the suspects demonstrates the deep commitment of many SAPS members."

"Now that these suspects are in custody, I urge the investigative team to build a watertight case that will stand up in court and lead to successful convictions. This will send a strong and unequivocal message that lawlessness will not be tolerated. Those who believe they can act with impunity must know that they will be tracked down and face the full might of the law," Marais added.

### Investigation reveals co-pilot's error during South **African Airways** turbulence incident

AN INVESTIGATION into an incident aboard a South African Airways Airbus 330-300 has revealed how a co-pilot ignored guidelines.

In October last year, four cabin crew members were injured when the plane flew into turbulence mid-air during a flight from Cape Town to Johannesburg.

According to reports, one crew member was seriously injured after being flung against the ceiling.

A report by the South African Civil Aviation Authority has shown that the Airbus began shaking while cruising at 41 000 The co-pilot, according to the

report, then tried to manually stabilise an overspeed instead of leaving the autopilot engaged. This caused the aircraft to

oscillate in pitch. The co-pilot told the inquiry

that she was concerned that if the speed brakes were used, it would worsen the situation.

However, a computer simulation conducted by Airbus showed that if the autopilot setting remained engaged and the speed brakes used, the plane would have landed smoothly and within safety limits.

Despite the chaos, none of the 211 passengers were hurt.
